## Invitation for Bids

The Palestinian Authority (PA) has received a Japanese ODA Grant (the Grant) from Japan International Cooperation Agency (JICA) on the basis of the Grant Agreement (G/A) signed on the 21st day of October, 2020, between PA and JICA concerning the Project for the Construction of Schools for the Improvement of Quality and Environment of Education (the Project). PA intends to apply the grant to eligible payments under the contract(s) for which these Bidding Documents are issued.

2. Central Tendering Department on behalf of PA now invites sealed bid from eligible bidders to construct of educational facilities for a school in Gaza Strip (GS) (the Works). This Bidding includes one contract lot for the Works. Information of the lot is summarized below.
